The following are hospitality and travel accommodation requirements for the members of "Radio JRNY".

These additional rider requirements will be agreed to by both parties and shall be binding in an addition to all other signed performance contracts.

This is for a performance to take place on _____, by and between Radio JRNY, hereinafter referred to as "PERFORMERS" and _____, hereinafter referred to as "PURCHASER".

Purchaser shall initial next to each applicable item on the rider to show purchaser's approval and acceptance. Please put N/A on any non-applicable items.

Air Travel

*Initial _____ • PURCHASER to provide five (5) round-trip tickets for PERFORMERS to the airport nearest the venue and to send the tickets, including full itinerary to PERFORMERS no later than 30 days prior to date of engagement. PURCHASER is to provide arrival for the PERFORMERS one night prior to date of engagement, and provide five (5) hotel rooms on the night of arrival in addition to five (5) hotel rooms for the length of the performance contract. PURCHASER can opt to send to the Performers the total cost of air-fare (in US dollars) for five (5) round-trip tickets no later than 60 days prior to date of engagement.

International Travel

*Initial _____ • PURCHASER is to provide and pay for any required visa's for international travel.

Ground Transportation

*Initial _____ • For performances where PERFORMERS are being flown in, PURCHASER is to provide ground transportation for PERFORMERS from airport to hotel and/or venue. Transportation vehicle must be large enough to accommodate five (5) band members, as well as PERFORMERS musical equipment and personal effects.

Hotel Accommodations

*Initial____ • PURCHASER is to provide five (5) separate rooms with a minimum three-star rating (AAA) within close proximity to the performance venue. PURCHASER must ensure that rooms are included for the night prior to the date of engagement, and throughout the entire duration of agreed engagement.

Meals and Refreshments

*Initial____ • PURCHASER to provide one (1) meals per day per member for agreed engagement dates.

Backstage Dressing Room at Venue

*Initial____ • PURCHASER shall provide a secure backstage dressing room close to the stage with adequate lighting, mirrors, towels, makeup lighting, clothes hanging rack, sitting area and a restroom. PURCHASER also shall provide cold refreshments including regular and diet soft drinks, one case of bottled water and beer (if permitted by the venue). A deli meat/veggie platter with breads and fruit in PERFORMER dressing room or backstage area for each date of agreed engagement.

Merchandise

*Initial____ • PURCHASER shall provide one (1) 8ft. table with 5 chairs with no arms or wheels, and audience control tape to form a line at merchandise booth to be provided by the venue to be ready by show time and labeled 'Merchandise'. Venue needs to provide an electrical outlet in close proximity to merchandise table.
